2. Hazards Identification

Emergency overview Irritating to eyes and skin. This is a consumer care product that is safe for consumers when used according to the label directions. 4. First Aid Measures

First aid procedures

Eye contact Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention if irritation develops and persists.

Skin contact Remove and isolate contaminated clothing and shoes. Wash off immediately with plenty of water. Get medical attention if irritation develops and persists.

Inhalation Move to fresh air. Call a physician if symptoms develop or persist.

Ingestion Rinse mouth thoroughly. Do not induce vomiting. If ingestion of a large amount does occur, call a poison control center immediately. Never give liquid to an unconscious person.

General advice Call a physician if symptoms develop or persist. Ensure that medical personnel are aware of the material(s) involved, and take precautions to protect themselves.

5. Fire Fighting Measures

6. Accidental Release Measures

Personal precautions Keep unnecessary personnel away. Keep upwind. Keep out of low areas. Keep people away from and upwind of spill/leak. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. In case of spills, beware of slippery floors and surfaces.

Environmental precautions Prevent further leakage or spillage if safe to do so. Do not contaminate water.

Methods for containment ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Use water spray to reduce vapors or divert vapor cloud drift.

Methods for cleaning up Should not be released into the environment. Dike far ahead of spill for later disposal. Avoid dust formation. Wipe up with absorbent material (e.g. cloth, fleece). Following product recovery, flush area with water.

Never return spills in original containers for re-use.

7. Handling and Storage

Handling DO NOT handle, store or open near an open flame, sources of heat or sources of ignition. Protect material from direct sunlight. Avoid contact with skin. Avoid contact with eyes. Do not use in areas without adequate ventilation. Avoid prolonged exposure. Wash thoroughly after handling. Avoid release to the environment.

Storage Keep away from heat, sparks and open flame. Room temperature - normal conditions. Keep container tightly closed. Keep out of the reach of children. Use care in handling/storage.
